AND

Demonstrate at least 12 months of cumulative employment (full-time equivalent) within the last 5 years in a regulated education and care service in Australia, supported by verifiable evidence.

OR

Hold the CHCSS00147 Entry into Diploma of early Childhood Education and Care.

As well as balance part-time or full-time employment with study and have suitable language, literacy, and numeracy skills for Diploma level learning.

Training Program

Students complete learning and assessments through **mixed-mode delivery over 12 - 24 months**, including:

- Workplace based learning
- Practical observation and assessments
- Employer reports
- Knowledge questions, logbook tasks and case studies
